New Business:

#### Thorofare Plan

A letter from Mrs. Wm C. Coker was read protesting the extension of Boundary Street northward across her property as shown on the Thorofare Plan.

#### Election Officials

A letter signed by Charlie Maddox was read requesting that negroes be appointed as election officials.

#### Zoning

The Board discussed a recommendation from the Zoning Board of Adjustment to consider the zoning existing in Glen Heights. Alderman Giduz moved that this matter be referred to the Planning Board to be included with other areas for an overall study, seconded by Alderman Walters, and passed.

#### Elections

Alderman Giduz stated that the County contemplate changing the voting precincts, and discussed this together with changing the Town's precincts to make voting easier for Town residents and from an economical standpoint also. The Board requested the Mayor to meet with the County and discuss the matter.

#### Zoning

Alderman Giduz inquired as to the present status of the Sion Jennings rezoning on Durham Road. Alderman Giduz moved that Town Manager be given authority to execute an agreement with Sion Jennings requesting an additional six months time, or until the area involved is rezoned to a substantial zoning, seconded by Alderman Walters, and passed.

Mr. Phil Green stated that applicants may apply for the commercial zones now available, but does not think they may apply for a commercial rezoning unless the type is clearly stated.

#### Cemetery

Alderman Strowd inquired as what progress is being made about beautifying the cemetery. Town Manager stated that the weather has been a hindrance, but something will be done soon.
