ARTICLES OF INCORPORATION

OF

Wake Forest Rescue Squad, Inc.
(Name of Corporation)

A NON-PROFIT CORPORATION

We, the undersigned natural persons of the age of twenty-one years or more, acting as incorporators for the purpose of creating a non-profit corporation under the laws of the State of North Carolina, as contained in Chapter 55A of the General Statutes of North Carolina, entitled "Non-Profit Corporation Act", and the several amendments thereto, do hereby set forth:

1. The name of the corporation is Wake Forest Rescue Squad, Inc.

2. The period of duration of the corporation shall be perpetual
(May be perpetual or for a limited period)

3. The purposes for which the corporation is organized are:
To acquire and own rescue apparatus for use by the corporation in the protection and rescue of persons from injury or loss of life; to own and acquire land and to construct buildings for use by the corporation in connection with the housing of rescue apparatus and for the providing of a place of meeting for the members of the corporation; to sponsor or hold rescue schools; to engage in any and all types of activities not prohibited by law which shall befor the betterment of the community, county and state.

4. The corporation is to have the following class or classes of members: (If there are to be no members, so state.)

- 1. Active Members
- 2. Honorary Members

5. Directors of the corporation shall be elected in the following manner:
By majority vote of the active members.

6. The address of the initial registered office of the corporation is as follows:

9. In addition to the powers granted corporations under the laws of the State of North Carolina, the corporation shall have full power and authority to

10. * The corporation shall have and issue no capital stock and shall be operated without profit. No part of the assets or income of the corporation shall be distributed to or inure to the benefit of any Member, director, or officer of the corporation or any private individual. However, reasonable compensation may be paid for service rendered to or for the corporation affecting one or more of its purposes.

In the event of dissolution no member, director, or officer of the corporation or any private individual shall be entitled to share in the distribution of the assets of the corporation but such assets shall be donated, transferred, delivered and conveyed by the directors to one or more organizations engaged in similar activities that have qualified under Section 501 (c) (3) or corresponding provisions of the Internal Revenue Code and have qualified under Chapter 105, Sections 125 and 139 of the General Statutes of North Carolina.
