Bird Flu and You

On March 13, 2006 I was invited to attend a Pandemic Planning Update meeting by Department of Health and human Services.

The 3 types of Flu discussed were **Seasonal** (or Common) flu which is a respiratory illness that can be transmitted person to person and a vaccine is available. **Avian** (or bird) flu is caused by influenza viruses that occur naturally among wild birds. The H5N1 variant is deadly to domestic fowl and can be transmitted from birds to humans. There is no human immunity and no vaccine available. **Pandemic** flu is virulent flu that causes a global out-

break, or pandemic, of serious illness. Because there is little immunity, the disease can be spread easily from person to person. Currently, there is no pandemic flu. There have been 3 influenza pandemics in the past: 1918-1919 (Most Severe) caused at least 5000,000 US deaths; 1957 -1958 (Moderately severe) caused at least 70,000 US deaths; 1968—1969 (Least severe) caused at least 34,000 US deaths.

It is everyone's own responsibility to be prepared when such an event occurs. The benefits of preparation will be many. States and communities will be better

prepared for any disaster. Preparation will bring peace of mind and the confidence that we are ready to fight a flu pandemic.

Version of Good Samaritan Volunteer Firefighter Assistance Act Signed Into Law

The final version of the Patriot Act, which was signed into law on March 9, 2006, included language similar to the Good Samaritan Volunteer Firefighter Assistance Act (HR 1088 and S 766). The original purpose of the legislation was to provide a company or fire department that donates fire control or fire rescue equipment to a volunteer fire company protection from liability for injuries or damage caused by a defect in the equipment. The protection does not extend to persons who act with malice, gross negligence or recklessness in making the donation.

The language, which goes into effect on April 9, 2006, is slightly different than the NVFC-endorsed legislation. It adds a caveat that in order to receive liability protection, donors must have the equipment recertified as meeting the manufacturer's specifications by a technician who has been certified by the manufacturer of fire control or fire rescue equipment to inspect such equipment.

NVFC is concerned that the new law creates a standard that is unreachable for organizations considering donating equipment. There is no existing entity that test used equipment for recertification or even an established process for doing so.

"Every year quality fire equipment, including hoses, fire trucks, protective clothing and breathing apparatus, with an estimated worth in the millions of dollars, is destroyed or discarded by industry and larger fire departments instead of being donated to small fire departments in order to avoid civil liability lawsuits," said NVFC Chairman Philip C. Stittleburg. "It is not clear how a donor would comply with the standard set in this new law. Even if it were possible to comply, the cost of recertification would be significant and it is doubtful that many manufacturers or donors would be willing to pay for it. The NVFC supports passage of the Good Samaritan Volunteer Firefighter Assistance Act as originally

written to protect donors and encourage increased giving to needy volunteer fire departments." HR 1088 was introduced on March 3, 2005, by Congressman Mike Castle (R-DE) and referred to the House Committee on the Judiciary. It has 74 cosponsors. S 766 was introduced by Senator Rick Santorum on April 4, 2005, and was referred to the Senate committee on the Judiciary.
