## Facts and Figures about the North Carolina Fire Service

- ◆ The latest figures show that there are 1,136,650 firefighters in the United States.
- ◆ Membership in the NC State Firemen's Association is 51,018.
- ◆ There are an estimated 30,300 fire departments in the United States.
- ◆ North Carolina has about 1,320 fire departments across the state, representing 1,534 Fire Districts.
- ◆ 41 are fully paid fire departments (3%)
- ◆ 247 are combination (19%).
- ◆ 1,007 are volunteer (78%). This is roughly an 80/20% split volunteer vs. career.
- ◆ There are approximately 47,000 firefighters in NC (9,400 career firefighters and 37,600 volunteers)
- ◆ A fire department responds to a fire every 20 seconds.
- ◆ Medical aid calls have nearly tripled since 1980.
- ◆ Fire departments respond to 3 emergency calls every 4 seconds, including a medical call every 2 seconds.

## EASTERN CAROLINA FIREFIGHTER'S ASSOCIATION

The Eastern Carolina Firefighter's Association, an affiliate of the North Carolina State Fireman's Association, serving four-hundred ninety-five fire departments in thirty seven counties of North Carolina. The service area borders the I-95 corridor from Virginia to South Carolina eastward to the Atlantic Ocean. In 2007, the Association had three-hundred thirty-six member departments and ten associate members.

The purpose of the Association is as follows:

- 1) To provide a vehicle for the exchange of ideas on improving the level of fire protection services in eastern North Carolina.
  - 2) To provide quality training programs for member departments and any other that may wish to participate.
- To act as a clearinghouse for information concerning legislation, technical data, and current items of interest to member departments with the understanding that legislative activities shall be coordinated with and carried on through the North Carolina Fireman's Association.
- To serve as a forum for representation of the member departments to all law and policy making bodies and their members.

The Association has several programs that benefit its members.

The Association awards two \$1,000 General Scholarships and one \$1,500 Emergency Services Scholarship annually. A new program initiated is the Fire Department Assistance Program. This program provides technical assistance and assistance in acquiring equipment to new departments or departments with financial need. The Association in partnership with the Cape Fear Community College annually sponsors the Eastern Carolina Firefighters Association Seminar. In 2007, over 700 students participated in training classes at this seminar.

The Association supports the National Volunteer Fire Council, the North Carolina Fallen Firefighters Foundation, NC Jaycees Burn Center and the Muscular Dystrophy Association. The Association urges all members to take the National Seat Belt Pledge and to wear seatbelts at all times. The Association also supports the NCSFA 25 in 5 program which is to reduce accidents 25% in five years.

## A MESSAGE FROM STATE TREASURER RICHARD MOORE



### North Carolina Retirement Systems Enhances Firemen's and Rescue Squad Pension Process

As firefighters and rescue squad workers, you work hard to keep our citizens and neighborhoods safe. As your State Treasurer, it is my honor and responsibility to ensure you can count on your pension benefits to be there for you when you need them.

The North Carolina Department of the State Treasurer has implemented a new technology called ORBIT (Online Retirement Benefits through Integrated Technology) and revised some of the forms that members of the Firemen's and Rescue Squad Workers' Pension Fund use to enroll, retire or withdraw from the pension fund. The new technology, coupled with the revised forms, will improve customer service and speed our processes.

One of the key changes related to forms will dramatically improve the Retirement Systems Division's response time for returning contributions, in the case of requests for refund or notifications of death. The new form will identify the source of contributions within the Turnaround document (TAD), differentiating the amount provided by the member versus the department. This is only one example of the improvements coming your way with ORBIT.

Other changes in the system should be seamless and will not affect your interaction with the Retirement System. ORBIT is designed and integrated to improve the Retirement Systems Division's service to you.

I also want to encourage you to enroll in the Firemen's and Rescue Squad Workers' Pension Fund, if you have not already done so, or apply for your monthly pension benefits if you are eligible. The Firemen's and Rescue Squad Workers' Pension Fund provides \$167 per month to retired firefighters and rescue squad workers who served our state and our citizens. Sometimes one payment can buy enough time to put a plan in place to provide long term assistance and save a families property. We are blessed to be able to offer assistance to our members when needed.
