## Executive Director - Paul Miller



### KNOW YOUR DEPARTMENT'S RELIEF FUND/PROTECT YOUR INTERESTS

How many of you are aware that your department has a relief fund? How many of you know who serves on your relief fund board? Do you know how the members of your relief fund board are appointed or elected? Do you know what you can do with your relief fund money or where it comes from? If you cannot answer these questions you need to do some homework. This fund and the board that governs it are one of the most important assets of your department.

Our concern is that many members still tell us today that they know nothing about the local relief fund. We hope that Chief 101 will take care of most of our concern, but we need to use every method available to get the word out. We see a need for more accountability for the funds and have some suggestions to make to our member departments that will help you avoid embarrassing problems in the future.

Funding for local department relief funds comes from insurance companies doing business in North Carolina. The funds are received by the state and paid out by the department of insurance to departments who meet the following three criteria: 1) Departments must be members of the North Carolina State Firemen's Association (who manage the funds), 2) Departments must send NCSFA a relief fund financial statement no later than October 31<sup>st</sup> of each year, and 3) Departments must complete and file a Report of Fire Condition with OSFM by January 31<sup>st</sup> of each year.

Each department participating in the relief fund must have a relief fund board in place. This is a five member board, two of which are elected by the membership of the fire department, two members are appointed by the governing body and one appointed by the Commissioner of Insurance upon a recommendation from the fire chief of the department. This local relief fund board has complete control over the investment and the expenditure of the funds, but it is important to note that NCSFA must approve the use of these funds unless it's a LODD situation.

The local relief fund can only be used to assist firefighters and their families and provide benefits for firefighters. Funds can be used to assist firefighters injured in the line-of-duty or their family if they should be killed in the line-of-duty. It can be used to assist destitute members who have served honorably for at least five years. It can provide scholarships, insurance coverage, retirement plans and other benefits for department members.

It is everyone's job to protect the fund. In the last several years we have discovered several cases of embezzlement of relief funds. Why did this happen and how did this happen?

No one kept a check on the funds or had proper accountability for the funds. Every department should require a report on the fund annually if not more often. That report should go to the department leadership and be shared with the entire department. It is public record and the fund belongs to the fire department. You should always require 2 signatures on checks. We recommend that the relief fund board treasurer and chairman be the signers. Another board member can be used as an alternate, but never allow a check to be written with one signature. All relief fund board members should have access to the bank statements, and they should review the statements monthly or quarterly to see that the deposits and balances are correct. If you have not instituted such practices we recommend that you start this process now. You can avoid future problems by doing so.

For those of you who would like more information on the local relief fund, it can be found in the general statutes. Go to [www.ncleg.net](http://www.ncleg.net) and bring up the general statutes on the right hand side of the page. Select Chapter 58 Article 84 for information on the relief fund. This short article in the statutes answers all of the questions asked above and more. You may also call our office for assistance when needed. We are always happy to assist you.

It is just good business to keep track of all department funds. This is especially true of the local relief fund. Institute a policy of good checks and balances and monitor your fund throughout the year. You do it in your home and at your business. You should do the same at your fire department.

I hope this article finds everyone doing well and enjoying this wonderful weather. At the time of writing this article eastern NC is in a "severe drought" and it is 100 degrees literally outside of my office. Gotta love that NC weather! In my articles I have been addressing the 4 F's of firefighting as I see it, Faith, Family, Friends, and the Fire Service. I wrote the last one on Faith. I will continue in the series about family.

Family, much like faith, is something we take for granted. We look at it as though it will always be there. I would beg to differ and would challenge you to look in your department. How many divorces are there in the fire service? EMS? Law Enforcement? If we spent as

much energy and compassion at home as we do in protecting our neighborhoods what would our marriage look like? What would our families look like? While there are legitimate reasons for divorce, have we exercised the same due diligence at home as we do in our fire service. With the type of calls we run on a near daily basis, having the ability to go home to a loving spouse and family is just as important to the health of you and the fire service as making sure there is water in the tank! You must take care of yourself mentally as well as physically. Be aware of stressors at work/home. Take an active role in identifying them and working for a solution. PTSD is not something we talk about. A neighboring EMS department had a suicide within its ranks and his co-workers said that they never saw it coming. When the cause was looked into it was found that marital problems led to his decision. Chiefs', would this come as a surprise to you if one of your employees were to commit suicide? Take an active role in "training" your firefighters in the responsibility of time management. This includes "QT" with their families. Firefighters, I encourage you to spend as much time in Maintenance and Care of your marriage as you do your apparatus at work! I can tell you from personal experience you will find reward in hard work! Anything that you put your hard work and sweat into will reap rewards! I leave you with this scripture Proverbs 14:23! Look it up!

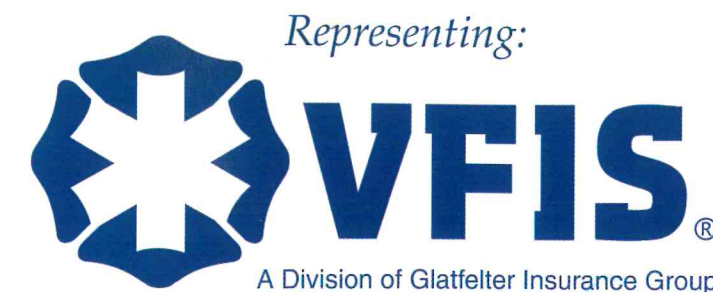
## Past President - Wes Greene



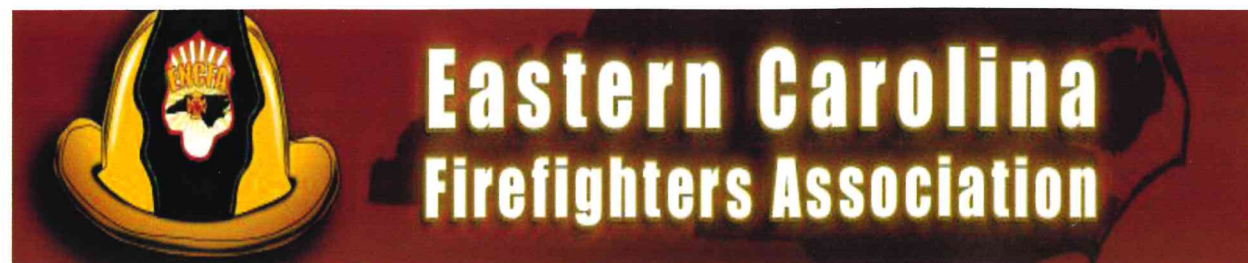

### Communicating Service Level Needs to Governmental Leaders

It was a shock I am sure for all of us to read the accounts recently of the adult male who drowned in California while Firefighters stood on the shore unable to act. You might be asking why they could not or why they did not act. That issue will be discussed for years to come, but simply put, the department budget was cut and one of the services that had to go was that of water rescue.

Unfortunately in today's economy fire departments and other response agencies are being placed in this difficult position and there are no easy answers. If we place our people in harms way without the appropriate training we risk the chance of injuring or killing a firefighter. If we do not commit our people then we run the risk losing a human life. This is a difficult position to be placed in and as fire service leaders we have to learn how to meet these challenges head on. The only real alternative we have in our line of work is to make sure we communicate to our local government leaders what we do (services provided) and why it is important (impact on the citizens we protect). There is no doubt that we are in an era that cuts are going to be made and until something happens that awakens the consciousness of the people who control the purse strings, we are going to have to continue to fight for the resources we need.

So how do we communicate our needs? Can we roll a casket into city hall and tell them that if we do not get what we requested people are going to die? That and other similar tactics are not going to work. Some tools to use that will work are facts. Facts such as what level of service you provide to all your taxpayers in terms of response time should not be communicated in averages but fractals. This way we can show service level disparities and how they affect our capacity to make a meaningful impact in terms of dollar loss from fire or from life threatening medical calls. We have to communicate effectively what the impact is if we close a fire station or take a ladder or engine company out of service.

Will we always win the fight or keep our resources? No, probably not, but that is not the end of the fight. If a service is cut or stations are not built we have to have the capability to show the story and communicate the impact the decision has had on service levels and the community as a whole. So how do we develop the capability to capture this data? Using NFIRS, GIS, Excel, and other similar records management systems are a great start to helping "paint" the picture to our elected leaders.

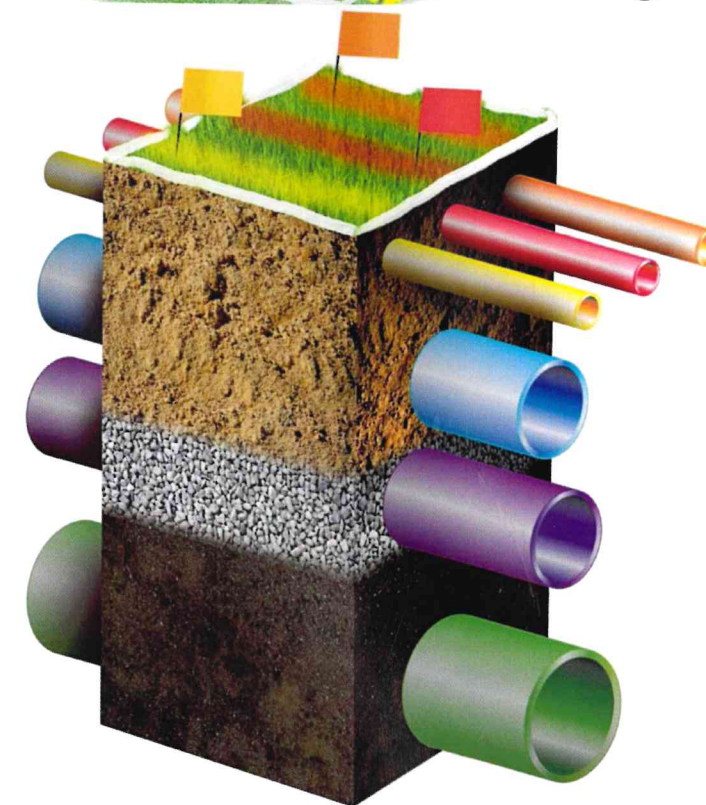


## Damage Prevention in North Carolina Dig the colors, they have a meaning



### Beware of what lies below – Dial 811

Before you start digging and run into problems, place a call to North Carolina 811 at least 2 working days, but no more than 10 working days before any digging begins.



A customer service representative will ask you to give all appropriate information related to the excavation.

The information is read back to you. You will be asked to verify its accuracy.









You will be given a list of utility members that will be notified.

You are given a reference number that is proof that you called. Keep the number for the duration of your excavation, or longer when applicable.

The utility companies then have 2 working days (not counting weekends or holidays) to come out and mark their lines.

When the lines are marked, you may begin digging with care.

# NCSFA Resolution



## Resolution Supporting Available Technology for the Purpose of Reducing Fire Loss and Personal Injury from Stovetop Cooking Fires

**WHEREAS:** Cooking equipment is the leading cause of residential fires and home fire injuries in the United States; and

**WHEREAS:** Unattended cooking is the leading factor contributing to cooking fires; and

**WHEREAS:** Electric ranges are the leading type of cooking equipment involved in these fires; and

**WHEREAS:** Unattended cooking and combustibles too close to the cooking surface, such as towels, paper products, etc., are major contributing factors to these fires; and

**WHEREAS:** Cooking fires are the leading cause of home fire injuries, these fires accounted for 40% of all reported home structure fires and 36% of home civilian injuries; and

**WHEREAS:** Education and code enforcement alone have not yielded the desired results when it comes to eliminating cooking fires; and

**WHEREAS:** Tested affordable technology for electric coil ranges now exists to drastically reduce the number of these fires and burned food incidents by reducing the high end temperature at which burners operate with no appreciable difference in cooking times or quality; and

**WHEREAS:** High-end heat regulation technology currently available can reduce the amount of energy used by the range by as much as 50%;

**NOW, THEREFORE, BE IT RESOLVED:** That the North Carolina State Firemen's Association supports this cooking "fire prevention" technology and further supports a modification of state and federal agency regulations to allow for this new fire safety technology to be utilized and will promote it by whatever means necessary in an effort to reduce or eliminate stovetop cooking fires.
