Committee.

President reads rules, Section 3, Article III, of Constitution, as follows:

"Every Fire Company in the State, which is a member of the Association, shall, on or before the 1st day of August in each year, elect two delegates and also two alternates, to serve for the ensuing year, with the Chief Engineer and First Assistant of the various departments, as delegates at large, who are entitled to one vote each. They shall be beneficiary members of the Association and shall show on our beneficiary roll."

There being several corrections to be made as to delegates in attendance, Chief Barnard moved that the report of the Committee on Credentials be adopted, subject to any changes that will be necessary afterwards. Seconded and carried.

President McNeill:

Those names who have been read out are entitled to a vote; every chief entitled to a vote, every assistant chief is entitled to a vote, every superintendent of water works is entitled to a vote, and every superintendent of fire alarms is entitled to a vote. Only

those entitled to vote can vote on all questions affecting the interests of the Association.

Next in order is the reading of the minutes of the previous meeting.

Mr. O'Neill:

Before we accept or adopt the minutes of the previous meeting, there are some corrections I think ought to be made. Last year in Wilmington, when you remember we were debating as to where we should meet this year, a motion was made ordering that the Association donate \$500 towards the entertainment of the tournament. I think that motion was carried. It does not appear in the minutes. There are other minor changes but I think that was a very important one and should receive some attention from the Association.

President McNeill:

I have no recollection whatever of its being carried, I know something was said about it.

Mr. Barnard:

I have a very distinct recollection of that, and if my memory serves me right, I am quite positive that motion was made by Brother O'Neill, and it was unanimous.

Mr. O'Neill:

I think the President was to get the money. He was to see that we got it at any rate.

Mr. Barnard:

I suppose there are others here who remember it.

Mr. _____:

Mr. O'Neill made that motion, and it was left to the Executive Committee but there was no vote taken.

President McNeill:

I recollect there was some talk about it, but we found it was impossible.
