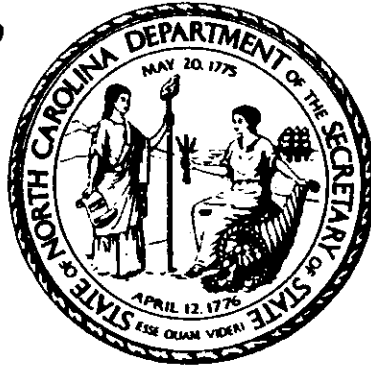

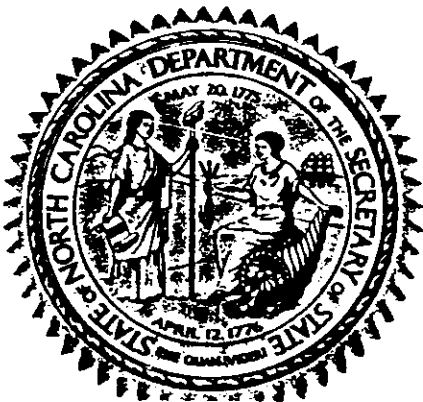

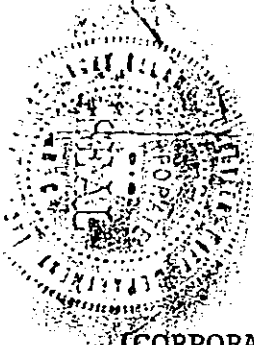
ARTICLES OF DISSOLUTION
